#### 3. Reports

- a. Trustee/Superintendent/Principal Announcements
  - Interim Supt. Neu and Principal Snekkevik provided a joint report regarding the status of small group in-person instruction and the potential for the re-opening of school as a whole.
    - An anticipated movement of Marin County from Tier 1 to Tier 2 for Covid-19 cases would have allowed the school to re-open on Sept. 21, but a last minute change in the metrics on Sept. 7 has kept the county in Tier 1. The county has appealed that decision and a response is expected within 24-48 hours. Once the county moves to a new tier, it must remain there for a minimum of three weeks. If the number of cases increases, the county will move back to Tier 1. The state is trying to move slowly and make the right decisions based on science.
    - For now, the school has the leeway to bring students on campus in small cohorts, which cannot exceed 25% of the total number of students enrolled at any one time. This has allowed students to meet with their teachers individually or in small group cohorts, and to get their homework.
    - Countywide, 15 waivers have been approved, most of them for private schools. One public school that received a waiver, Martin Luther King in Sausalito, was prepared to reopen, but a staff member tested positive, causing the re-opening to be delayed.
    - Nicasio School District will submit a waiver application by Friday, Sept. 11. The advantage of a waiver is that if all schools reopen in three weeks but the county returns to Tier 1, a waiver would allow Nicasio School to stay open.

- Information about Covid-19 testing by Kaiser has been provided to staff. For non-Kaiser member employees, testing is available at the Marin County Civic Center.
- Interim Supt. Neu said a new trustee will replace outgoing Trustee Rutledge and the District will make outreach and extend a welcome to him.
- Principal Snekkevik presented her report:

Public Hearing on the Nicasio School District 2020-21 Learning Continuity and Attendance Plan including the Budget Overview for Parents: The Board held a public hearing to solicit the recommendations and comments of members of the public regarding the specific actions and expenditures proposed to be included in Nicasio School District's 2020-21 Learning Continuity and Attendance Plan. Principal Snekkevik presented an overview of the plan. There was discussion about the state requirement for daily instructional minutes, which is 240 regardless of whether it is inperson, synchronous or asynchronous. Principal Snekkevik said daily instruction is currently being delivered in four 60-minute learning blocks, which will closely parallel the master schedule for when students return to campus. The district is required to document not just instructional minutes, but also chronicle the content and delivery of instruction. Interim Supt. Neu said the state has indicated that schools will be closely audited on instructional minutes and the mechanisms in place for documenting attendance. CBO Bonardi said the District's attendance documents are being reviewed by legal counsel to ensure they comply with state requirements. Principal Snekkevik noted that for the younger students, there has been a lot of asynchronous, independent work as well as four Zoom sessions per day with the teacher to get help and engage in community building. The public hearing was closed at 5:30pm.

#### 7. Action

a. Consider Approval of Unaudited Actuals for Fiscal Year Ending Jun 30, 2020 *Discussion:* CBO Bonardi said that overall, the District did very well this year. There were no major changes despite what had been projected at second interim. Salaries came in close to budget, but the District saved approximately \$56,000 on contract services due to the school closure in early spring. She noted that the better and stronger the District's reserves, the easier it will be to weather the next few years due to the current unpredictability of property taxes and State and Federal funding. As of this school year, everyone is on the salary schedule with no negotiations. The last negotiations covered 2018-19 and 2019-20. There are uncertainties with the certificated union because they do not a have a union president. CBO Bonardi commended the Board for its diligence in maintaining the District's reserves, noting it will put the District in a better position to withstand anticipated first interim budget changes. The Board thanked CBO Bonardi for a good report, in both form and content.

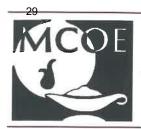

- Determine whether the adopted budget will allow the district to meet its financial obligations during the current fiscal year and is consistent with a financial plan that will enable the district to satisfy its multi-year financial commitments.
- Determine whether the adopted budget includes a combined assigned and unassigned ending fund balance that exceeds the minimum recommended reserve for economic uncertainties and verify compliance with disclosure requirements if above the minimum reserves.

Based upon our review, the adopted budget of the Nicasio School District has been approved.

#### STATE AND NATIONAL ECONOMIC INFLUENCES

Through our fiscal oversight role, we carefully monitor the economy, its impact on State and Federal revenues and how these might affect Marin County school districts and students. We also closely monitor changes associated with the accountability element of the Local Control Funding Formula (LCFF) as well as current legislative efforts, especially those impacting property and parcel taxes, the ongoing uncertainties associated with federal actions, the steady increase in pension costs despite recent State action to provide relief, and fiscal information unique to each district.

#### **Current Economic Conditions**

The 2020-21 California state budget as adopted has some significant differences for most school districts as budgets were based on assumptions included in the Governor's May Revise. The adopted budget increases the LCFF entitlement by 8% over that proposed by the Governor which was made possible by a combination of actions including deferring the payment of \$11 billion in state aid for 2020-21 until the fall of 2021. The adopted

budget also includes \$1 billion of restricted federal funding to address Learning Loss Mitigation. As a result, in accordance with Education Code 42127(h), school agencies have reported changes to the budget in what is known as the "45 Day Revision". Our review and approval of the District's adopted budget acknowledges the changes made with the 45 Day Revision.

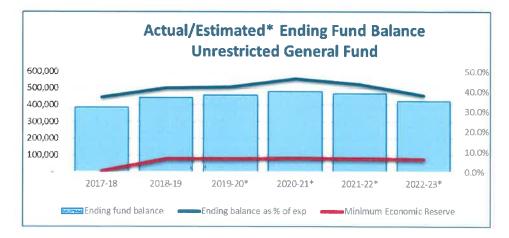
The District is dependent on local economic conditions for revenue growth, as the rise in the local property taxes is the primary source for revenue increases. As we look to the future the property tax growth rate is estimated to outpace the state's economy in most areas of Marin. We are, nonetheless, cautious about the property tax growth rate as the COVID 19 pandemic is having an unprecedented impact on economies at all levels – local, state, national and global.

For education funding to remain at current levels in 2021-22 and beyond, the state will need a significant increase in revenue: Absent any increase in revenue collections, education funding will, on the natural, decrease in 2021-22 as the current year's reductions were averted by increasing the State's deferral debt and using other one-time sources. The upcoming ballot includes Proposition 15 known as the Split Roll, a property tax measure to tax commercial properties at current assessed value. If passed this measure would distribute 40% of the net increase in tax revenue to school districts and community colleges. An additional property tax measure to allow certain homeowners to retain a portion of their historic property tax base when they move would, conversely, lower the state's reliance on property taxes to fund schools.

The COVID-19 pandemic is having an uneven impact on the economy. Although the stock market continues to show record increases, California's unemployment rate rose to a high of 16.4% in May 2020. While the rate had fallen to 13.3% in July 2020, this compares to 4% in July 2019. The current unprecedented level of uncertainty coupled with both known and unknown cost pressures underscores the need to maintain budget reserves and fiscal flexibility. It is within this context that school districts should exercise caution when considering out-year spending commitments to ensure they are well positioned for what could be an extended economic recession and unknown period of recovery.

#### **BUDGETARY POSITION FOR NICASIO SCHOOL DISTRICT**

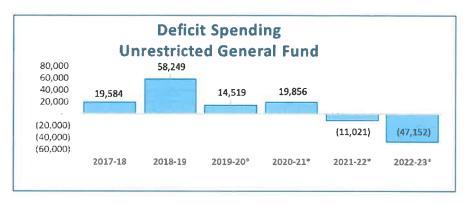
The following graph depicts the District's estimated ending balance in the adopted budget and multi-year projection for the unrestricted general fund with both the state required minimum reserve and the District's actual reserve as a percentage of total expenditures.



The District's ending balance meets the minimum required reserve requirement for the current and two (2) subsequent years. The District's unaudited actual financial statements for 2019-20 may show an improvement that will increase reserves.

#### **OPERATING DEFICITS**

The District's adopted budget reflects operating deficits in both subsequent years of the multi-year projection for the unrestricted general fund as displayed in the chart below.



The cumulative impact of this projected deficit spending is a 5% decline in fund balance in the four (4) years ending June 30, 2023, leaving the District with reserves of \$0.4 million or 38% of general fund expenditures at June 30, 2023. The restoration of unrestricted revenues in the state adopted budget has an immaterial impact for the District's budget, therefore, the District will need to begin to plan for budget corrections to cure the deficit.

While some deficit spending may be planned, the ongoing nature of structural deficits threaten a school district's future educational programs. Districts that wait too long to address and correct structural deficits are forced to make dramatic corrections all at once. In contrast, carefully planned and phased-in structural corrections lessen the impact on children.

#### **CASH FLOW**

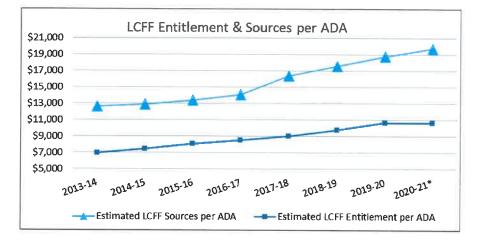
The budget includes a significant amount (\$11 billion) of principal apportionment cash payments deferred from 2020-21 to 2021-22 with final cash distributed in November 2021. When a district is deficit spending both fund balance and cash reserves are decreased. The combination of deficit spending and state deferrals make historical cash flow statements less reliable indicators of future cash needs. All districts should ensure they have a robust system for projecting and monitoring cash flow to ensure sufficient lead time to implement any necessary cash-flow borrowing.

We note the District has prepared for potential cash flow needs by requesting borrowing capacity from the County of Marin through a Tax Anticipation Note (TAN) which has been approved by the Board of Supervisors. Any District with cash flow needs beyond April 1<sup>st</sup> should ensure they have an existing TAN in place prior to April and will also need to execute the newly available TAN Addendum. Finally, should a district need cash flow borrowing across the fiscal year into 2021-22, the district will need to execute a promissory note with the County of Marin.

The District is well advised to maintain reserve levels at far higher levels than the state required minimums to ensure sufficient cash for operating purposes.

#### LOCAL CONTROL FUNDING FORMULA (LCFF) FOR NICASIO SCHOOL DISTRICT

The final budget holds all Local Educational Agencies (LEAs) harmless at 2019-20 student attendance (ADA) and funding levels. While the restoration of the LCFF to flat funding is extremely good news for all school agencies, the core revenue and economic outlook assumptions remain unchanged. Moreover, representatives of the



Legislative Analyst's Office (LAO) generally agreed with the administration's core assumption that COVID-19 is a multiyear problem that may result in further deterioration of the state's fiscal condition in 2021-22.

As portrayed in the graph above, which is based on the state's adopted budget, as a community funded district, the District's property taxes exceed the LCFF entitlement and the District is therefore reliant on growth in the property tax base for increases in unrestricted revenues. While the District's property tax growth rates were on track with growth in the LCFF entitlement for many years, the District's property tax growth is now anticipated to outpace growth in LCFF funding in the adopted budget and multi-year projection

The District has an obligation under the new funding formula to direct the supplemental grant included in the District's LCFF entitlement towards increasing or improving services to pupils of higher need. This requirement applies to all districts, including community funded districts and is documented in the District's Learning Continuity and Attendance Plan. The District's estimated 2020-21 LCFF supplemental grant is almost \$21.5 thousand representing a requirement to increase or improve services in the budget year for pupils of higher need by 5.7% as compared to all other students.

#### **PROPERTY TAX TRENDS**

Property taxes provide 92% of the District's total unrestricted revenue sources. The following chart shows the growth in total property tax revenues as well as the actual secured tax growth rates through 2019-20 and the County of Marin's preliminary tax roll for 2020-21.



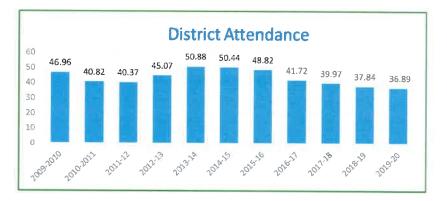
#### COMMUNITY FUNDED DISTRICTS - BASIC AID

Community funded districts are commonly called "basic aid", which refers to the basic aid entitlement for all students of \$120 per average daily attendance (ADA) as set forth in the California Constitution as defined in Education Code Section 41975. Ultimately, basic aid districts receive the benefit of excess taxes which exceed their LCFF entitlement.

An additional constitutional guarantee began with the passage of Proposition 30 in 2012. Drafted as a means of guaranteeing benefit to all schools, Proposition 30's Education Protection Act (EPA) provides that no school district shall receive less than \$200 per Average Daily Attendance. The temporary income taxes and minimum funding guarantee authorized by Proposition 30 were extended with the passage of Proposition 55 at the November 2016 election for another 12 years through 2030.

#### **STUDENT ATTENDANCE**

The final budget for 2020-21 holds student attendance (ADA) flat at 2019-20 levels with very limited exceptions none of which apply to Marin county school districts. In place of traditional attendance accounting, the state is allowing districts to use alternate accounting and compliance elements during the COVID-19 pandemic designed to ensure minimum daily instructional minutes, daily student participation and engagement, especially when the instructional program is conducted by distance learning.



#### **FEDERAL BUDGET**

The Nicasio School District will receive \$22 thousand in one-time revenues primarily funded by the federal Coronavirus Aid, Relief, and Economic Security (CARES) Act to address Learning Loss Mitigation. The bulk of these funds must be expended by December 30, 2020 on a range of allowable uses with the focus on mitigating learning loss that may have occurred with the closure of schools in the spring due to the COVID-19 pandemic. The additional revenues and associated expenditures should be included in each district's budget no later than the first interim budget update due December 15, 2020. The cash associated with the bulk of these one-time revenues is being distributed to schools in September to ensure districts have sufficient cash to implement planned actions.

The federal budget for fiscal year 2021 is being developed against the backdrop of the pandemic and a stalemate between the Senate and the House over additional emergency funding. Federal funding for California school districts is forward funded, meaning that the 2021 budget will determine federal revenues in the District's 2021-22 budget. We will continue to monitor events in Washington closely.

#### PARCEL TAXES

Your community has shown support for its schools through a parcel tax. The District's multi-year projection includes parcel taxes in all three (3) years starting with a base of \$0.2 million in the adopted budget representing 19% of the District's total general fund revenue sources. The District's current parcel tax is escalated 3% annually and expires on June 30, 2025

#### SALARY SETTLEMENTS

We note that the District has not settled negotiations with either bargaining unit for the budget year. Due to the ongoing nature of these costs, any permanent increases to salary require permanent and ongoing funding sources. When the District and bargaining unit are ready to settle negotiations, Government Code 3547.5 requires the District to publicly disclose costs, as certified by the superintendent and chief fiscal officer. Please provide a Public Disclosure of Collective Bargaining Agreement including the tentative agreement(s) and multi-year projection to our office ten (10) working days prior to Board approval. Budget revisions associated with salary settlements should be approved within 45 days of Board approval.

The legislation enacting the state budget for 2020-21 included language prohibiting the layoff of classified staff in specified functions including child nutrition services, transportation and custodial services. Therefore, during the 2020-21 year, we encourage districts to consult with legal counsel when considering any staffing layoffs.

#### **PENSION CONTRIBUTIONS**

The state budget for 2020-21 redirected funding appropriated under Senate Bill 90 enacting the 2019-20 budget to buy down the 2020-21 and 2021-22 pension contribution rates rather than being used to buy down the long-term rates. This action provides pension relief for both CalSTRS (teachers retirement system) and CalPERS (classified employees retirement system). The District's adopted budget includes pension relief savings of approximately \$9.9 thousand. While the state's actions have provided some welcome relief to the budget, pension contributions will increase again beginning in 2022-23.

#### RESERVES

The District maintains the state-required minimum reserve for economic uncertainty of \$71 thousand in the current and two (2) subsequent years. In addition, we note the District maintains a Board reserve for economic uncertainty of \$186 thousand for a total reserve of \$257 thousand in all three (3) years of the budget and multi-year projection.

All school districts, whether state aid or community funded, are well advised to establish higher than minimum reserves in order to provide for the financial flexibility to absorb unanticipated expenditures without significant disruption to educational programs, cash flow deferrals and general economic uncertainties. Higher than minimum reserves allow the District to better ensure a consistent and stable program offering for students.

#### **Transparency Requirement**

The District met the requirement of disclosing reserve levels, including justification for carrying higher than minimum reserves, at the adopted budget public hearing.

#### **Cap on Reserves**

Should the Public School System Stabilization Account (PSSSA) equal or exceed 3% of state general fund revenues, a cap on district reserves is effective in the following fiscal year. The reserve cap does not apply to community-funded districts or districts with less than 2,500 ADA. Additionally, if triggered, districts may request an exemption from the reserve cap from the county superintendent of schools. The reserve cap has not been

triggered for the current year and is not anticipated for the two (2) subsequent years. In all circumstances, we continue to encourage districts to maintain higher than minimum reserves.

#### LEARNING CONTINUITY AND ATTENDANCE PLAN

We commend the District's efforts in preparing the Learning Continuity and Attendance Plan which has taken the place of the Local Control and Accountability Plan (LCAP) for the 2020-21 year only. The new plan is not subject to County Superintendent approval, although written comments may be addressed to the District's governing board for review in a public meeting. The Budget Overview for Parents, which is normally associated with the LCAP, is still required for 2020-21 but with an amended timeline delaying the document to December 15<sup>th</sup> for submission with districts' first interim budget updates.

#### CONCLUSION

We thank Margie Bonardi for the timely submission of the adopted budget using the statutorily required forms and responsiveness to the requests for information made in the course of our technical review.

We appreciate your dedication and service to the children of Marin County.
