Health and Welfare Benefits

This document sets forth the policies of the Nicasio School District for classified employees. It includes: benefits for health, dental and vision care; holidays, sick time, personal leave, and vacation; as well as policies regarding retirement.

This document differentiates benefits for employees who are full and part-time. The definition of full-time for classified staff is as follows:

Definition of Full-Time

Classified Staff working 180 school days:

For employee benefit purpose, full-time for classified staff is defined as working 6 hours and 20 minutes per day, 180 days of the year (following the school calendar). In defining benefits for classified staff, a full time employee is one who works between 0.75 and 1.0 full time equivalent (FTE).

Classified Staff working more than the 180 school days:

For classified staff working more than 180 days, their FTE status is prorated based on 8 hours/day per 12 months. In defining benefits for classified staff, a full time employee is one who works between 0.75 and 1.0 FTE.

Health Benefits

Medical benefits consist of dental, vision and health care.

Classified employees may receive medical benefits in accordance with the Classified Personnel Health & Welfare Benefits Matrix (E 4254). Medical benefits available to classified employees are determined by their position classification and FTE status.

For all classified employees eligible for medical benefits, enrollment in a dental and vision plan is non-voluntary. In such cases, employees must first enroll in a dental and vision plan; any remaining funds available up to the cap (or prorated cap in the case of eligible part-time employees) may be applied towards a health care plan.

The District does not provide cash in-lieu of medical benefits.

Sick Leave

Classified Staff working 180 school days:

Classified staff who work full time (according to the definition of FTE above) are entitled to 10 days of sick leave (Education Code §45190-45210).

Classified Staff working more than the 180 school days:

Classified staff who work full time (according to the definition of FTE above) are entitled to 12 days of sick leave (Education Code §45190-45210).

Classified staff who work less than 0.75 FTE receive prorated sick leave.

Vacation

Classified Staff working 180 school days:

Classified staff who work full time (according to the definition of FTE above) are entitled to 7 pre-approved days of vacation leave (Education Code §45190-45210). Pre-approval is defined as one week in advance.

Classified Staff working more than the 180 school days:

Classified staff who work full time (according to the definition of FTE above) are entitled to 10 days of vacation leave (Education Code §45190-45210).

Classified staff who work less than 0.75 FTE receive prorated vacation leave.

Holidays

Classified staff are entitled to 10 paid holidays per year provided they are in paid status during any portion of the working day immediately preceding or succeeding the holiday (Education Code §45190-45210).
